28 Pray for Gray Foundation was born from the vision of its founder, Julie Fletcher, to have an event in Fargo, North Dakota that would emulate her experience attending "Humor to Fight the Tumor" event she had attended in Minneapolis, Minnesota. The idea is to bring family, friends, and associates together for an evening of education, inspiration, and awareness of what individuals and families have to deal with when a loved one is diagnosed with a brain tumor. Pray for Gray aspires to be an evening filled with hope, to educate and to raise awareness of brain tumors, to help meet the needs of other brain tumor patients and their families, and to ultimately raise funds for new research and patient services. In 2017 Pray for Gray raised funds for the Mayo Clinics Department of Clinical Research via an annual dinner and action gala. In 2017 there was a per plate dinner with a silent and live auction venue with entertainment. There was also a "fund a cause" live auction where attendees chose to make a donation to a family/cause of the events choosing (most likely a family in need of financial assistance due to medical costs associated with their cancer fight). The intent is to have honorees which will share their stories to educate the audience on their battle with the disease. Each year volunteers will donate their time to find attendees, corporate donors, auction donors, and time to set up the event. There are no plans to employ persons to fill these rolls, but to create a network of volunteers to make the gala a success.
