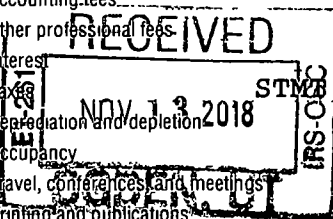

THE STANLEY AND EVE GELLER FAMILY FOUNDATION (THE "FOUNDATION") IS A PRIVATE FOUNDATION ESTABLISHED BY STANLEY AND EVE GELLER (DECEASED). STANLEY GELLER IS THE PRESIDENT. AT THE TIME THE 2017 TAX YEAR FORM 8868 WAS FILED TRANSMITTING PAYMENT OF \$475 (SLIGHTLY BELOW THE MAXIMUM AMOUNT PERMITTED TO BE PAID BY CHECK) COMPLETE FINANCIAL RECORDS FOR THE 2017 TAX YEAR WERE NOT YET AVAILABLE. THE AMOUNT PAID WAS ESTIMATED TO BE ADEQUATE TO COVER THE 2017 TAX LIABILITY BASED UPON TAX LIABILITY FOR THE PRIOR YEAR; E.G., THE 2016 TAX DUE WAS ONLY \$189. AT MR. GELLER'S ADVANCED AGE (OVER 90), HE IS NEITHER EXPERIENCED NOR COMFORTABLE WITH THE USE OF THE MANDATORY ELECTRONIC FEDERAL TAX PAYMENT SYSTEM.
