In 2017 we made a change in how we are supporting the children in Uganda. In prior years we financed all expenses at Jireh Children Center near Masaka Uganda. In August we moved all of the children from that center to a new school, Masaka Baptist School and ceased support at Jireh Childrens center. Suubi Lyabana is a communitay based organization registered in Masaka for the sole purpose of overseeing the distribution of funds to the various organizations that currentkly care for over 250 children on behalf of US2UGANDA4life. In addition to supporting children at Masak Baptist primary school we also support children at Hope comprehensive secondary school, yesu akawagala secondary school, vocational schools and various Universitles

Prior to moving our children to Suubi Lyaabana and since the inception of our organization we supported all of our children through Jireh Childrens center. The grant provides for all of the needes of over 250 children at the center through May 2017.

In addition to supporting the two institutions above we also support Kalungi Medical Clinic and nursing school. Our support here is more through bringing medical students to Uganda to assist at the facility and less about providing finances.
