This donation from Supernatural Marriage Ministries to Hope Mission in Vijayawada, India was used to construct three meeting facilities, and a home for a pastor and his family. Hope Mission pastors teach in the villages to married and single individuals, helping them to learn the principles needed for establishing and maintaining healthy relationships. Much progress has been made. The divorce rate among those they teach has dropped considerably. Families are thriving because their interpersonal relationships have improved. These homes & facilities are used throughout the year. They are newly constructed of durable materials, and should be useful for many years.

4b (Code:) (Expenses \$ 37,800 including grants of \$) (Revenue \$)
Supernatural Marriage Ministries provided these funds to help cover the cost of housing, feeding, and educating 400 orphans, 75 widows, and 75 dowry castaway wives cared for by Hope Mission near Vijayawada, India. The recipients have no other place to live safely. While being cared for they are taught principles of self care for the future, and instructed in ways of developing and maintaining healthy relationships. Their standard of living and life relationships have been improved greatly through these donations.

4c (Code:) (Expenses \$ 91,990 including grants of \$) (Revenue \$)
These funds were donated by Supernatural Marriage Ministries to Amen & Amen Community Care Center near Kampala, Uganda. The money was used to build a dormitory, fence, bathroom, provide transportation, and buy office equipment. There is a school and an orphanage at this center where children are taught how to live successful lives, and how to have healthy interpersonal relationships. Over 300 children are schooled and cared for by Amen & Amen.
