The experienced and certified educators, specialists and therapists provided a multi-disciplinary approach to focus on each child's specific strengths and capabilities. In addition to the individualized education, each student received therapies (Physical/Occupational/Speech/Music) based on an Individualized Developmental Plan (IDP) and input from each student's parents/guardians.

Summer Escape is a summer camp for children and teens with special needs, between the ages of 5 and 21. Every week had an overall theme and daily activities including music time, arts and crafts, dance parties, etc.
