Operation Ground Zero - The Source Foundation
The Source is our operational "door" to the world of Aceh. It is licensed as an Achenese NGO, actually in the name of an Indonesian. We cannot operate without the Source. This grant funds the basic operations of that foundation, including a Preparedness/Response Local Coordination Center (LCC), logistics for visiting teams, management of Ujung Karang Conference Center (UKCC), aka Sabang Retreat Center & Micro Business Loans. Also includes Operational, Financial Literacy, Basketball, Member Care, Disaster & Emergency Funds and training.

YSI-ICF Aceh Sustainable Peace
To see the people of Aceh enjoy an increased quality of life having been equipped to help both themselves and their neighbors. Mission is to channel resources to alleviate the suffering of the people of Aceh while empowering local people to achieve sustainable community development. Aceh is the worst affected location as a result of the 2004 tsunami, with massive loss of life and destruction of infrastructure. The people of Aceh have also suffered during armed conflict that lasted more than 30 years. Methodology includes establishing pilot projects of plantation and nurseries for cash crops and animal husbandry which are being used as a showroom and training center for agricultural projects in neighboring villages. Serving 450 families, 2000 people.

UKCC Operations
Ujung Karang Conference Center (UKCC) is a stand-alone facility on Weh Island, Indonesia. UKCC was built for the purpose of providing relaxation, encouragement and a safe retreat for the workers of Aceh Province. To be sustainable in this location the facility must generate it's own income. However, for this to be done, solid infrastructure as well as an increase in bed capacity must occur. This expense was for the operational costs required for UKCC to provide solid infrastructure as it pursues development towards financial autonomy.
