

We provide free and low cost veterinary services to low income pet owners from two mobile veterinary hospital trucks. In 2017 we made preliminary expenses to open our animal hospital and adoption center. In 2017 we treated 6,527 pets of low income pet owners. We also provided free veterinary services for approximately 424 animals, at a cost of \$63,922, which was 6% of our gross. We paid off \$219,099 of the mortgage on our new building.
