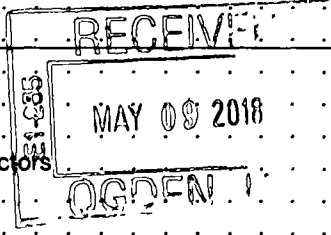

29 Event Production. FoCo Roller Derby holds events open to the public called 'bouts.' These bouts, or games, provide opportunity for our members to exhibit skills gained during member practice, and spectators to watch athletic roller derby competition.

On average, 20 members participate in the event and 161 spectators purchase tickets for a bout. In 2017, 1293 spectators attended eight (8) bouts from February through November. Holding these events is key to our mission statement and allows us to generate funds necessary to pay for venue rental used for practices.

30 Travel for Tournaments. Tournaments provide an opportunity for our most competitive players to travel and compete with other teams in our Division. In 2017, 20 skaters, coaches, and volunteers benefited from paid travel expenses for three (3) tournaments.
