We have a formal application and board review process in place, and all distribution information is carefully tracked and documented.  This donation was used to purchase equipment for Smilow's Scalp Cooling Program Support. The Scalp Cooling Program is used to help prevent hair loss during chemotherapy and radiation treatments.

 Comfort Kit Baskets donated to individuals fighting cancer
 This program has been one of our mainstays since our original formation. It involves the procurement, assembly and donation of "comfort kit" baskets to individuals who are undergoing treatment for breast cancer. Such baskets include unique food, personal hygiene, clothing and related items that are specially focused on the needs of treating cancer patients, particularly those undergoing chemotherapy. Kits include items such as oral hygiene products, teas and ginger for nausea, warm socks, a sleep cap and more.
