Rocky Mountain BEST provides a forum for youth to develop technical skills through a robotics program in which youths partner with engineering and science professionals in the local community to design and build competition robots.

06. Part III, Line 28

The Hub Program provides at no cost hardware and software components and technical assistance to teachers and schools who choose to participate in the BEST robotics program. We host the local competition event. In 2017 we had 29 schools compete with approximately 400 students. We also provided grants to 26 schools competing in Hubs across Colorado with more than 40% Free and Reduced Lunch to help those schools defray costs of competition. Schools could use the funds for tools, transportation to the competition, food for team meetings, etc. at their discretion.

07. Part III, Line 29

The Regional Program hosts the Regional event for the winners of 5 local competitions from all across Colorado, this year involving schools with approximately 350 students. This was our first Regional competition and we hope to host more teams in 2018.

Part III, Line 30

The New Hub program is our way of helping new Hubs get on their feet. This year we served as a fiducial sponsor for Pikes Peak BEST in its inaurural year as a BEST Hub. They were awaiting 501(c) (3) status, so we helped them raise funds for their first set of teams. They hosted 8 teams in their first year, providing the same free competition as our Hub Program in line 28.

08. Part III, Line 31

We have two other small programs, one that provides some training for teachers and mentors with teams competing in our Hub program. They receive (free) 2 days of training on the BEST program, and how to help their teams succeed, a second program is an outreach program to let educators, students, parents know about Rocky Mountain BEST and its Robotics Competition. Finally, we have one program where we keep track of all expenses that apply across all of the programs. For example, audit charges, software such as gotomeeting, web maintenance, etc.
