Our mission is to expand global access to low-cost clean water technologies and information about health and sanitation through knowledge-sharing, training, community-building, peacemaking, and sustainability. Through community training in the use and construction of BioSand filters - not only is sustainable clean water technology available but the local filter building teams form the basis of small micro businesses creating a sustainable source of the filters and clean water for the community.

BioSand Filter Construction - Community Training: we offer community training programs in the construction of BioSand Water Filters. Each training is geared towards training 20-35 individuals in the production and safe use of BioSand filters. The trainings are generally 5-6 days in length and covers both filter construction, as well as health and sanitation training. Along with the hands on construction training, FWFW provides multiple reusable steel molds (for filter construction) as well as tools and materials needed to produce filters for all the training participants. These are provided at no cost to the participants for their continued use. In 2017 we offered trainings in India, Democratic Republic of Congo, Kenya, Tanzania, Rwanda, Uganda, Burundi, and Ethiopia. In 2017 we expanded our community training program to pilot projects in Sierra Leone and Liberia. We offer our training to communities that may be suffering discrimination or severe health or economic hardships. We have been working with displaced minority groups in Congo (Batwa Pygmies), India (displaced women) Tanzania (people with albinism) and Uganda (with victims of gender based violence) and throughout east in communities impacted by HIV/Aids. In 2017 FWFW conducted over 27 community trainings and trained over 80 filter building teams.

Rainwater Catchment and Microflush Composting Toilet Construction training: In 2017 FWFW expanded our water and sanitation training to include construction of cement rainwater catchments (cisterns) and construction of microflush (low water use) composting toilets. The rainwater catchment training was held in Uganda and coincided with a FWFW meeting of East African Team leaders. 5 teams were trained in the siting and construction of cement rainwater catchments. FWFW provided training, tools and materials to begin construction. The trained teams will offer their services to communities, schools and individuals who wish to expand their local water storage capacity. These facilities are expected to be used in conjunction with BioSand filters. It is expected that the teams will charge for their services and through those funds be self sustaining. Later in the Year FWFW offer another training in the construction and use of micro flush composting toilets. This was done on a pilot level with the emphasis on expanding use near schools and orphanages. Again FWFW only subsidize the training and the starter material. It is expected that the local teams will hire out their services and be self-sustaining.

BioSand Filter Card Fund program. This program allows FWFW to place biosand filters in schools clinics and orphanages or with families struggling with HIV/Aid. This program is done in conjunctions with local filter building teams that have been previously training by FWFW. FWFW pays these local teams to build and install the filters where they are needed. Requests for filters are sent to FWFW through these local teams. In 2017 FWFW was able to subsidize and install over 300 filters in orphanages and with families that needed them.
