Rapha House operates several safe houses for girls that are rescued from sex trafficking and other forms of exploitation. The safe houses provide a safe place for these girls to recover and heal through basic care, counseling, education, social work, and legal advocacy. Each safe house gives child survivors the chance to reclaim their lost childhood. Each day girls are treated with love and value instead of abuse and neglect. Our safe houses are staffed by trained experts from the local community who understand the culture and know how to work with children through comprehensive and trauma-informed care. By walking with these girls on their healing journey, we are helping them reach a life of sustainable freedom.

Rapha House reaches out to impoverished communities where children are at risk of being victimized. Through our Kids Club sponsorship program, sponsors give children education opportunities and our goal is to prevent trafficking and exploitation before it ever begins.
