The organization provided disaster relief in the form of financial assistance to Maxim employees, family members of Maxim employees, and others who were victimized by natural disasters. In response to Hurricane Harvey, Hurricane Irma, and Hurricane Maria, the foundation distributed \$33,500 to or for the benefit of 33 financially needy individuals to ensure victims had the resources to obtain basic necessities, such as food, clothing, housing (including repairs), transportation, and medical assistance.

4b (Code) (Expenses \$ 33,034.00 including grants of \$ 33,034.00) (Revenue \$)

The organization provided shelter relief in the form of financial assistance to Maxim employees, family members of Maxim employees, and others who were challenged with eviction or foreclosure. The foundation distributed \$33,034 to or for the benefit of 27 financially needy individuals to ensure they had the resources to remain in their current housing or obtain affordable housing in order to avoid homelessness.

4c (Code) (Expenses \$ 32,524.00 including grants of \$ 32,524.00) (Revenue \$)

The organization provided hardship relief in the form of financial assistance to Maxim employees, family members of Maxim employees, and others who were disadvantaged by illness or death of an immediate family member. The foundation distributed \$32,524 to or for the benefit of 38 financially needy individuals to ensure they had the resources to obtain basic necessities and to manage the burden of the costs associated with illness and death.
