The mission is to bring reliable and sustainable healthcare to the South Sudanese people in South Sudan and the refugee camps in northern Uganda where many were replaced due to the civil war. The mission is accomplished by our doctors and nurses providing medicine and healthcare through a clinic in northern Uganda and working directly in the refugee camps

Salaries of doctors and staff at the clinic in South Sudan and northern Uganda. Due to the civil war in South Sudan, the HKF doctors went to northern Uganda to serve the South Sudanese refugees with medical services and provide a clinic there. The mission and services stayed the same, only the location changed. The Healing Kadi Foundation raises funds to cover the salaries and wages of the doctors, nurses, pharmacists, and other personnel who form our medical team. Although there were no specific gifts designated for salaries of the clinic personnel, the general funds and other fund-raising events covered the cost.

4b (Code:) (Expenses \$ 29,244 including grants of \$) (Revenue \$ 32,049)
Mission trips to Kajo Keji, South Sudan and the refugee camps in northern Uganda. A couple of smaller medical teams traveled to South Sudan and later to northern Uganda to set up clinic operations there to serve the million plus refugees. This was a pass through amount as each participant paid their own way, but was channeled through HKF who made all the arrangements and paid all expenses.

4c (Code:) (Expenses \$ 20,000 including grants of \$) (Revenue \$ 98,972)
Medicine and Mosquito Nets for Refugee Camp. Through several channels, medicine was purchased to take to South Sudan on the Mission trips. Some money was also given specifically for the purchase of medicine. We also did a special event drive to raise money for mosquito nets for people in the refugee camps in northern Uganda. This is an ongoing project through 2018 and 2019.
