Cambridge Community Center for fitness equipment upgrades, field house lighting upgrades, and two  
sets off retractable basketball hoops. The \$450 was to the local high school lacrosse program.

sales tax, State of Vermont business fees, and miscellaneous supplies.

Part II Line 24 – This is a cash balance in our Ameritrade account used to accept charitable stock donations (none for 2017)

Part III (primary exempt purpose) - Cambridge 360, Inc. was formed to provide a sustainable funding  
source for community recreation and wellness with the ultimate goal of establishing, maintaining, and  
growing a central community center for all ages in Cambridge, Jeffersonville, and neighboring communities.

Part III Line 28 – The largest project we undertook this year was to fund the addition of two sets of  
basketball hoops for the community center. There are numerous clubs and organizations within the  
community that will be served by adding hoops to the slate of offered activities including adult and  
youth leagues, as well as various organizations offering tournaments and clinics for all ages.

Part III Line 29 – This project was part of the initial field house renovation and was for the installation portion  
portion of the overall LED lighting upgrade started in 2016. The community center now has the most  
energy efficient and cost effective dimmable lighting system.

Part III Line 30 – This was funding for additional equipment and lockers for the fitness gym to enhance  
the offerings for community fitness and provide valuables storage for community members using the facility.

Part III Line 31 – Smaller amounts funding were provided to the community center for various upgrades
