

Furnishings and materials such as books, furniture, meditation cushions, outdoor seating and patio, as well as candles, incense, oils, and fabrics for meditation totaled \$9,332. The entire cost of maintaining our online platform and services including the video and audio hardware and software required for such services totaled \$4,528.
