THE GREEN SPORTS ALLIANCE MOVED FORWARD WITH ITS GOALS TO FURTHER GROW THE GREENING MOVEMENT IN 2017. BELOW ARE A FEW HIGHLIGHTS AND CHALLENGES OF 2017. ALTHOUGH WE SAW A DECREASE IN SUMMIT SPONSORSHIP DOLLARS, WE DID SEE AN INCREASE IN PARTNERSHIP DOLLARS THAT WENT TO FUND MANY NEW PROGRAMS AND RESOURCES TO MEMBERS THROUGHOUT 2017, INCLUDING 11 WEBINARS, AWARDED THE 2017 ENVIRONMENTAL LEADERSHIP AWARD AND 10 ENVIRONMENTAL INNOVATORS OF THE YEAR AWARDS CELEBRATING THE ACHIEVEMENTS OF THE SPORTS GREENING MOVEMENT, HOSTED A CHAMPIONS OF GAME DAY FOOD SYMPOSIUM IN PHILADELPHIA, PA FOCUSED ON SUSTAINABLE CONCESSIONS, WASTE REDUCTION, AND FOOD RECOVERY IN STADIUMS, AND BEGAN WORK ON THREE NEW RESOURCES FOR OUR MEMBERS: FAN ENGAGEMENT PLAYBOOK, PAPER USE PLAYBOOK, AND PLAYING FOR OUR PLANET. SUSTAINABLE SPORTS IN AN EFFORT TO FURTHER PROTECT THE GREEN SPORTS ALLIANCE BRAND AND AFFILIATED PROGRAMS/MARKS, ADDITIONAL INTERNATIONAL TRADEMARKS WERE FILED INCLUDING JAPAN, AUSTRALIA, KOREA, INDIA, NEW ZEALAND, EU, AND THE UK. ALLIANCE MEMBERS, BOARD AND STAFF PARTICIPATED AND CONTRIBUTED TO THE CONTENT OF MANY 2017 INDUSTRY CONFERENCES, INCLUDING IAVM, AASHE, AND SMA. THE GREEN SPORTS ALLIANCE ADDED MANY NEW MEMBERS IN 2017, RAISING THE TOTAL NUMBER OF TEAMS, VENUES, LEAGUES, FANS, AND EVENTS TO OVER 500. THE ALLIANCE ADDED ADDITIONAL MEMBERS TO THE CORPORATE MEMBERS NETWORK, WHICH CONVENES BUSINESS LEADERS WITH THE GOAL OF PROMOTING ENVIRONMENTALLY-PREFERABLE GOODS AND SERVICES IN THE SPORTS INDUSTRY. 2017 HELD STAFFING TRANSITIONS AND RESTRUCTURING, RESULTING IN THE ADOPTING OF 5 FULL-TIME STAFF MEMBERS: EXECUTIVE DIRECTOR, DIRECTOR OF PARTNERSHIPS, DIRECTOR OF OPERATIONS, MEMBERSHIP MANAGER, AND OPERATIONS & PROGRAM COORDINATOR. MEMBER RETENTION FELL SLIGHTLY, BUT SAW AN INCREASE IN NEW MEMBERSHIP IN THE YEAR. SPONSORSHIP ON THE OTHER HAND, HAS SEEN REDUCED RENEWALS AND RENEWAL AMOUNTS. AGING A/R REMAINED HIGHER THAN DESIRED IN 2017, AS A RESULT OF CHALLENGES COLLECTING MEMBERSHIP DUES AND SPONSORSHIP FUNDS IN A TIMELY MANNER. CONSEQUENTLY, THE ALLIANCE HAD TO WRITE OFF \$44,750 IN UNPAID INVOICES FROM BOTH 2016 & 2017. THE ALLIANCE'S PARTNERSHIP WITH A THIRD-PARTY MARKETING/COMMUNICATIONS TEAM WAS DISSOLVED IN 2017, RESULTING IN UNFORESEEN EXPENSES THAT WERE NOT ANTICIPATED. WITH THESE CHALLENGES, THE ALLIANCE HAD A NET LOSS FOR THE YEAR OF 2017. A STRATEGIC PLANNING SESSION WAS HELD IN 2017, TO FURTHER FOCUS ON OUR ORGANIZATION'S STRUCTURE AND GOALS MOVING INTO 2018. THE STRATEGIC PLANNING SESSION ALSO FOCUSED ON STRATEGIES FOR DECREASING AGING A/R, IMPLEMENTING TIMELY COLLECTION PROCESSES, AND UPDATING THE ALLIANCE WEBSITE IN AN EFFORT TO FURTHER INCREASE MEMBER/SPONSOR VALUE AND EASE OF DUE COLLECTION/RENEWALS. IN ADDITION, THE FOLLOWING ARE PARTNERS WHO, THROUGH THEIR GENEROSITY, HAVE DONATED IN-KIND RENTS OR SERVICES TOWARDS OUR MISSION: LNS CAPTIONING- \$5,050, WEBINAR CAPTURING SERVICES FOR OUR ANNUAL WEBINARS AND FOR OUR 2017 SUMMITBIOCYCLE- \$7,815, MEDIA PROMOTIONGREEN BUILDING & DESIGN- \$13,000, MEDIA PROMOTIONIAVM- \$17,000, MEDIA PROMOTION FOR 2017 SUMMITINNOVATION & TECH TODAY- \$28,200, MEDIA PROMOTION FOR 2017 SUMMITPANSTADIA- \$5,000, MEDIA PROMOTION FOR 2017 SUMMITRENEW MERCHANTISE- \$4,000, PRESENTED 2017 SUMMIT FASHION SHOW AND CURATED THE DEVELOPMENT OF AND MANAGEMENT OF DESIGNS FROM STUDENTSSTADIA MAGAZINE- \$5,000, MEDIA PROMOTION FOR 2017 SUMMITTERRACYCLE- \$5,000, MEDIA PROMOTION FOR 2017 SUMMITTRIPLE PUNDIT- \$5,000, MEDIA PROMOTION FOR 2017 SUMMIT US COMPOSTING COUNCIL- \$5,000, REGISTRATION FOR TRADE SHOW
