Explanation: Due to reasonable cause and not due to willful neglect (as described further below), the Form 990 was not filed in a timely manner with the IRS. During the tax year, Issachar Initiative ("the Organization") underwent a change in control, as disclosed on the Form 990. As a result of this change in control, the Organization became an integrated auxiliary of Campus Crusade for Christ, Inc., ("the Church"), EIN 95-6006173, an organization which is exempt under 501(c)(3) and is classified as a church. In connection with this change in control, the leadership and management of the Organization was changed from officers, directors, and employees of the Organization to officers, directors, and employees of the Church. The Organization's Board was further changed such that all Board members are appointed by the Church and such that a majority of the Board members are officers, directors, or employees of the Church. The Organization had previously filed a short-period Form 990 to change its year-end from September 30th to December 31st, effective December 31, 2016. As a result of the substantial changes in the leadership of the Organization, the Church's staff responsible for the filing of the Form 990 were not made aware of the first change in the Organization's fiscal year-end to December 31st. Therefore, a Form 990 extension request was timely prepared and filed for what was believed to be the Organization's fiscal year-end of September 30, 2017. In the summer of 2018, after the initial filing deadline of the Form 990 for the year ended December 31, 2017, the new management of the Organization became aware of the changes in fiscal year and the requirement to file the Form 990 for the year ended December 31, 2017. The Organization's management immediately engaged the assistance of a CPA firm to assist the Organization in the preparation of the Form 990 for this year. While the Organization's management made every effort to gather information in an efficient manner, additiona

Explanation: I time was required to gather all records and information necessary to prepare a complete and accurate return. The Organization is filing this Form 990 for the tax year ended December 31, 2017 promptly after the completion of the preparation of the return. Under Treasury Regulation 301.6522-2 (f), the penalty for late filing is waived if the failure to file the return in a timely manner is due to reasonable cause and not to willful neglect. While reasonable cause is not specifically defined in this Regulation, Treasury Regulation 301.6724-1 indicates that reasonable cause exists if the filer establishes that there are significant mitigating factors with respect to the failure, or the failure arose from events outside the filer's control. Moreover, the filer must establish that the filer acted in a responsible manner both before and after the failure occurred. Prior to the substantial changes in Organization leadership and prior to the multiple changes in the Organization's fiscal year-end, the Organization had a history of timely filing prior Forms 990 as required. The fact that prior to the failure, the Organization had an established history of complying with the information reporting requirement with respect to which the failure occurred is considered a mitigating factor as outlined in Treasury Regulation 301.6724-1 (b)(1). The Organization has also demonstrated that it is acting in a responsible manner as outlined in Treasury Regulation 301.6724-1(d) by taking appropriate actions to prevent potential future late-filings of Form 990. The Organization's new leadership and management is now aware of the Organization's fiscal year-end and of its requirement to timely file annual Forms 990 with the IRS and the corresponding due dates. Additionally, the Organization engaged a CPA firm specializing in nonprofit tax compliance issues to prepare the Form 990 for the tax year ended December 31, 2017. The Organization intends to engage the CPA firm to prepare future Forms 990

Explanation: as required. In addition, as an integrated auxiliary of the Church, the Organization has filed the Form 8940, Request for Miscellaneous Determination, with the IRS to request written confirmation that it qualifies for exemption from the Form 990 filing requirements for all fiscal years beginning on or after the date on which the Organization became an integrated auxiliary of a church. The Organization expects to receive written confirmation of this request and expects to be exempt from filing the Form 990 for future tax years. Therefore, as evidenced above, the late filing of the Organization's Form 990 for the year ended December 31 31, 2017 was due to reasonable cause and not willful neglect on the part of the Organization. The Organization therefore respectfully requests that the IRS not impose the penalty under Internal Revenue Code 6652(c) for failure to file this return.
