Of the homeowners we helped, 53% were over 65 years of age, 47% of the homeowners live with a disability, and 19% of homeowners are Veterans or widows of Veterans. Most of the homeowners are living on Social Security as their only source of income making it difficult to afford the repairs needed to provide a safe and healthy home. We are grateful for our 117 volunteers who gave over 1160 hours of their time to ensure our neighbors have a safe and healthy home. In 2017 we were able to reduce our expenses by \$39,619 due to \$32,419 in labor donations and \$7,200 in rent donations.
