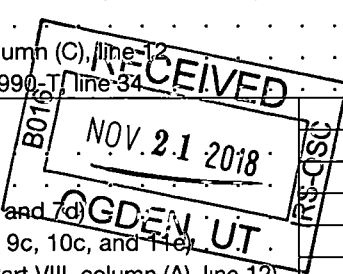

Iringa Hope Joint SACCOS: This is a SACCOS whose members are registered village SACCOS (Savings and Credit Cooperative Societies under Tanzanian law). This acts like a micro-finance bank supporting the network of Iringa Hope Village SACCOS. Annual loans augment the village SACCOS capital to enable making more loans to their members. Interest is charged which provides the Joint SACCOS with income, part of which is used to support the operating costs of the Iringa University Micro-Finance Institute. Our goal is to build this facility to the point where it will fully support the Institute's annual operating budget. There are now 30 village SACCOS members in the Joint SACCOS.

Develop Village SACCOS: Iringa Hope makes funds available to the Iringa University Micro-Finance Institute to give grants to new and existing village SACCOS to bring up their paid-in capital so they are able to make more loans to members. Funds provided by Iringa Hope are not always used in the year the grant is made. Nearly 33 village funds are now operational and most of them have been registered. There are several villages currently working to establish their SACCOS.

Integrated Development Centers: To provide dedicated space for the village AMCOS and SACCOS, work was started in 2015 on an Integrated Development Center (IDC) building. An IDC will be used for member training classes and other meetings in addition to space for receiving and holding agriculture products. This first IDC was completed early in 2016. During 2017, construction was completed on six additional IDC buildings. The construction costs for these six IDC buildings was funded with grants from the Peter J. King Family Foundation.
