In 2015 we assisted the City of Louisville in developing new approaches to heroin abuse and jail overcrowding. We helped the U.S. Department of Veterans' Affairs understand challenges around 'on-boarding' veterans into crucial health services, and we also launched a new effort with VA to improved veteran services overall by using human-centered approaches.
