Chevra provides humanitarian aid to needy Jewish people, many of whom are elderly and Holocaust survivors in the former Soviet Union and in Israel, by operating soup kitchens and distributing food parcels, warm clothing and medicine to those who are in need.

We partnered with our sister organization in Israel to provide humanitarian aid to new immigrants and impoverished Jews in Israel. We have very little overhead to administer this service so most of these designated funds are sent to provide these needed services. In Israel, we are helping not only new immigrants, but also the elderly, Holocaust survivors, single mothers and the disabled.

We support soup kitchens in Zaporoshe, Ukraine, which feeds many people each month in addition to our typical humanitarian aid in the entire country of Ukraine, which has been very hard hit by conflict in recent years. The grants we made to Ukraine were supplemented by undesignated donations over and above those we received specifically designated for our Ukraine ministry
