The organization's mission is to provide health care education and services globally, with emphasis on Dr. Sima Yaftali's native country of Afghanistan. The organization manages a medical clinic in Kabul, Afghanistan. The organization also produces and broadcasts educational health care shows globally via Ariana Afghanistan Satellite Television.

Office Visit - the organization manages a medical clinic in Kabul, Afghanistan, and treats patients for very low cost or even for free, depending on the patient's economic situation. The clinic charges low office visit fees to prevent misabuse of the organization's services. Expenses include the salary for 12 employees (medical doctors, nurses, staff, etc) as well as operating costs of the clinic. The revenues represent office visit fees. The clinic treated on average more than 900 patients per month in 2017.

4b (Code:) (Expenses \$ 57,671 including grants of \$ 0) (Revenue \$ 32,984)

Pharmacy - The clinic sells medical drugs to patients for very low cost or provides them for free, depending on the patient's economic situation. Expenses include the cost of purchasing the medical drugs as well as the cost of salary for 2 pharmacists. Revenues represent the proceeds from selling medical drugs. The clinic's pharmacy department sold or provided medical drugs on average to more than 700 patients per month in 2017.

Educational Health Care Shows - the organization produces educational health care shows and broadcasts them globally over Ariana Afghanistan Satellite Television. Dr. Sima Yaftali pays for the expense of producing and broadcasting the shows from her own personal finances. The educational health care shows do not produce any revenue for the organization. Many of the educational health care shows are available to the public at no cost on the organization's website: www.health-for-everyone.org.

Core services include treating patients (office visit) and providing patients with medical drugs as necessary (pharmacy).

Form 990 Part VI 11b (Process around Form 990) - on a monthly basis, Dr. Esmat Asem, the medical doctor and director of the medical clinic in Kabul (Afghanistan), sends a cash and expense report, along with copies of receipts for each expense to the Treasurer, Alex Yaftali. Alex Yaftali conducts a reconciliation of the reporting with all receipts to make sure all funds are accounted for. In addition, Alex Yaftali reviews the report with Dr. Sima Yaftali, the Executive Board Director, to provide an overview and answer any questions that may arise. At the end of the year, Alex Yaftali uses these monthly reports, along with other reports that are maintained throughout the year (to track donors, cash balances, etc) to prepare Form 990.

Form 990 Part VI 19 (Disclosure) - Health For Everyone makes its governing documents, policy documents, and financial statements available to the public during the tax year upon request.

Form 990 Part V (Tax Compliance) - all of the organization's paid employees work in the medical clinic in Kabul, Afghanistan. Therefore, US withholding taxes on compensation do not apply. All of the organization's directors located in the United States are volunteers and are not compensated.

Part VI Section A Line 2 (Relationships) - Dr. Sima Yaftali and Dr. Robert Ghaussy are sibilings and work together at Conejo Medical Center in Thousand Oaks, CA. Alex Yaftali and Nina Yaftali are the children of Dr. Sima Yaftali. Jill Davies works for Dr. Sima Yaftali and Dr. Robert Ghaussy at Conejo Medical Center. All these individuals are volunteer board members and are not compensated by Health For Everyone.

Schedule D Part VI (Land) - the medical clinic resides on property that is owned by the Ghaussy family, not Health For Everyone. The construction of the medical building was primarily funded by another non-profit organization (AMZ Foundation) and the Ghaussy family. Health For Everyone donated \$10,000 to help fund the construction of the building. This tax return states Health For Everyone's land and building assets at the historical cost of its contributions to build the facility (\$10,000).

Schedule D Part VI (Equipment) - Health For Everyone invested another \$30,000 in medical equipment in 2017. However, Health For Everyone is restating the investment in medical equipment for the years 2013 - 2016 from \$72,260 -> \$58,760. Total cost of equipment is \$58,760 + \$30,000 = \$88,760.

Form 990 Part X (Balance Sheet) - in addition to new investments in Equipment in 2017, Health For Everyone is re-stating line 10a of its balance sheet to adjust the value of major equipment purchases made each year from 2013 - 2016 (see above). Health For Everyone states building and equipment at cost. This adjustment, along with performance of Health For Everyone's public investments (stocks & bonds), largely explains the difference in the change in Net Assets from the prior year
