**Preserve WV AmeriCorps program is Preservation Alliance of West Virginia's statewide service initiative where AmeriCorps members help main streets thrive, help communities capture their local history, and preserve beloved historic landmarks in West Virginia. In 2017, PAWV deployed 49 AmeriCorps members (an increase of 10 from 2016) throughout the state to nonprofit organizations and local government agencies for one-year service terms. During their service, AmeriCorps members completed historic preservation projects and managed volunteers. AmeriCorps service projects include coordinating heritage and educational events, preserving historical resources, and developing educational materials.**

**Field Services is Preservation Alliance of West Virginia's statewide, on-site, technical assistance program. Staff and other professional experts provide technical assistance to those wanting to preserve historical places, as well as organize historic preservation work days at historical sites. One major sub-program is the West Virginia Endangered Properties program, which highlights historical places that may be lost in West Virginia if action is not taken on the property. Those properties that are listed are focal points of technical assistance, etc.**

**The 2017 West Virginia Historic Preservation Awards was the ninth annual awards banquet, which was held at the Municipal Auditorium in Charleston on September 30, 2017. Three \$500 grants were given to the following: Crawford Holdings, Friends of the Old Stone Cemetery (Lewisburg), and Friends of Mt. Wood Cemetery (Wheeling).**
