Through the hospital's home health provider, Miami Valley Hospital Foundation provided funding for an Advanced Illness Management (AIM) Health Coach to provide education and care coordination to improve patient self-management of chronic illness. Additionally, the Foundation provided a comprehensive program for COPD patients with an emphasis on Respiratory Therapy Intervention, to help patients and their caregivers better understand how to manage their disease at home. In 2017, the AIM program served 258 patients resulting in a 45.35% reduction in 30-day readmissions, and a 28.33% reduction in total encounters. (Continued on Schedule O)

Form 990, Part III, Line 4b:

The Hospital Elder Life Program (HELP) is designed to promote a safer and more enjoyable hospital stay for older adults. By combining the skills and resources of hospital staff and volunteers, the program helps to minimize delirium. HELP interventions are focused on safety, thinking exercises, pre-mobilization activities including bed and chair exercises, nutrition and hydration assistance, sleep promotion, and breathing exercises to prevent respiratory complications, and feet pumps to prevent blood clots. In 2017, the Elder Life Specialists conducted 4,596 patient visits.

Promise to Hope's mission is to promote healthy families by providing a safe, accepting place where addicted mothers can receive the help they need to recover. The program partners with the Alcohol and Other Drug agencies in our area to coordinate comprehensive recovery care for pregnant women who are addicted to opiates. This care includes Medication Assisted Treatment, group and individual counseling as well as prenatal care and other social services. Care coordinators assess each patient's needs and connect her with the most appropriate agencies that can assist. Over 300 moms have enrolled in Promise to Hope since its inception in May 2015.
