Once the scores were compiled, the Committee met as a whole to award the specified amounts based upon scores. Ms. Schultz and Mr. Disbrow removed themselves from discussions regarding the amount awarded to their granddaughter's or grandson's awards. In 2017, Ms. Schultz's Granddaughter was awarded \$2,500. In 2017, Ms. Schultz's Grandson was awarded \$1,500. In 2017, Mr. Disbrow's Grandson was awarded \$1,750.
