HEALTHPATH BEGAN TO OFFER INTERMEDIARY SERVICES TO OTHER FOUNDATIONS AND GOVERNMENT ORGANIZATIONS. DURING 2017, HEALTHPATH PARTNERED WITH PRIVATE FOUNDATIONS AND ONE GOVERNMENT ORGANIZATION TO REGRANT AND/OR SERVE AS THE FISCAL AGENT FOR INITIATIVES BASED IN OHIO. FOR EXAMPLE, HEALTHPATH BECAME THE FISCAL AGENT FOR THE CHILDREN'S ORAL HEALTH ACTION TEAM (COHAT) AND CHANGED THE NAME TO ORAL HEALTH OHIO, COMPLETED A STRATEGIC PLANNING PROCESS, HIRED A FULL-TIME COORDINATOR AND ATTRACTED OUTSIDE FUNDING TO SUPPORT THE WORK.
