David Meyers is the CEO of ERG, Inc. whom Coastal Quest has a resource sharing agreement with. David Meyers has no direct relationship with Coastal Quest. Coastal Quest does contract with ERG, Inc. and receives services as outlined in the resource sharing agreement at cost, in other words ERG, Inc. does not make any profit on the services provided to Coastal Quest. Coastal Quest received a reimbursement grant from California Ocean Protection Council and Coastal Quest needed to pay in advance 14 small grants for collaboratives. California Ocean Protection Council's grant has a 10% contingency hold, and David Meyers provided a loan at fair market rate to cover the small grants made to the 14 collaboratives. \$126,000 of the \$140,000 principal was repaid to David Meyers in 2018.

Tegan Hoffmann is Vice President at ERG. This company provides services to many clients including Coastal Quest, which paid ERG for services in 2017 under the resource sharing agreement between the parties, at no profit. The resource sharing agreement was approved by the Board of Directors with Tegan Hoffmann abstaining from the vote, as she is an ERG employee. She was not paid directly by Coastal Quest for any services that she provided through ERG.
