Part V, question 1c - "Yes" is answered to this question. However, the organization was NOT subject to backup withholding rules for reportable payments to vendors and reportable gaming (gambling) winnings to prize winners. That is, the organization did comply.

Part V, question 2b - The organization's only "employees" are remunerated as ministers in accordance with IRS guidance. As such, they are not subject to withholding for Social Security and Medicare taxes and/or federal and state income tax withholding. Accordingly, there are no requirements for quarterly filing of forms 941, etc. However, forms W-3 and W-2 were filed to report ministers' 2017 remuneration.

Part VI, Section B, line 11b - Those charged with governance are provided for a personal review Form 990 and all of its related attachments at the time it is ready for filing. Each officer was asked to review the documents before their submission to the organization's president for signature and the subsequent filing of the 990. Additionally, all trustees were provided the same opportunity.

Part VI, Section B, lines 12a-14 - The organization regularly and consistently monitors compliance with conflicts of interest by periodic meetings of its trustees (governance) and, frequently, with others involved on a voluntary basis in achieving its mission. The nature of the organization's activities is such that risks of conflicts of interest are extremely remote. This answer is provided even though "No" is the correct response. All governance members consider a whistle-blower policy as unnecessary. Additionally, there is no document retention and/or destruction policy except to maintain records suitable for compliance with all statutes and regulations for records maintenance and retention to which the organization is subject under state and federal laws.

Part VI, Section B, line 15b - None of the organization's trustees or officers are compensated in any manner whatsoever, nor have they ever been. The only "key employees" are ministers whose remuneration is made in compliance with rules, regulations and other guidance for ministers' compensation. Trustees set ministers' remuneration after careful consideration of responsibilities, expectations and comparability data. Contemporaneous substantiation of the deliberation process and decisions is made.

Part VI, Section C, line 19 - All records of the organization are available for public inspection if the inquiring party has a legitimate interest in supporting the organization's mission or there is otherwise a need to know or a legal requirement underlying a request.

Part XI, line 9 - Unlike in the 2016 Form 990, there was no rounding error in preparing the Form 990 from the organization's accounting records. There was, however, a \$1 rounding error in Schedule D's Part VI for "Land, Buildings, and Equipment."
