Form 990, Part III, Line 4a,	The Institute was recently ranked among the top five organizations with the greatest research impact in immunology worldwide by the rating agency Thomson-Reuters. In addition, four of its scientists are among the most highly cited immunologists in the world—a distinction held by less than half of one percent of all publishing scientists. One of them, Prof. Dr. Shane Crotty's made the list for the second year in a row in recognition of his pioneering studies on vaccine-related immunology. Illustrating the caliber and impact of LJI's researchers, Dr. Alessandro Sette's team has been named Best Academic Research Team as part of the 10th Vaccine Industry Excellence Awards at the World Vaccine Congress 2017. The ViE Awards celebrate the outstanding contributions and achievements of leaders who continually set standards of excellence and advocacy in vaccine development. Dr. Klaus Ley has been selected as the 2017 winner of the Eugene M. Landis Award, the Microcirculatory Society's top honor, in recognition of his pioneering work in vascular biology and microcirculation. In 2017, La Jolla Institute launched the Center for Asthma Prevention and Treatment dedicated to understanding, treating and solving the problem of asthma. A joint endeavor between LJI and UC San Diego Health, the center will bring together patients, clinicians and researchers to accelerate the development of individualized asthma treatments based on patient-specific disease markers. The wide range of expertise coming together at the Center for Asthma Prevention and Treatment made an immediate impact. It allowed a team of physicians, scientists and bioinformaticians affiliated with the center to successfully compete for a \$8.5 million grant to establish one of only ten PreciSE Network Clinical Centers nationwide. The PreciSE Network is an initiative funded by the National Institutes of Health/National Heart, Lung and Blood Institute, to advance precision medicine for patients with severe and exacerbation-prone asthma. 2017 Notable Research Results: In 2017, LJI research teams made discoveries meriting publication in leading peer-reviewed scientific journals: 135 papers in all, continuing a trend of very high productivity. 40 of them appeared in high impact journals, which is a measure of the research's pioneering nature and influence. Together, they illustrate the range and power of immunology research, the caliber of LJI's faculty and their impact on a broad group of human health issues. Some of the highlights among papers published in 2017 include: Dr. Alessandro Sette and his collaborators found the first direct evidence that autoimmunity—in which the immune system attacks the body's own tissues—plays a role in Parkinson's disease, the neurodegenerative movement disorder. The findings raise the possibility that the death of neurons in Parkinson's could be prevented by therapies that dampen the immune response. The idea that a malfunctioning immune system contributes to Parkinson's.

Form 990, Part III, Line 4a,	ates back almost 100 years But until now, no one had been able to connect the dots Plus, scientists long thought that neurons were protected from autoimmune attacks Dr Sette's findings show that two fragments of alpha-synuclein, a protein that accumulates in the bra in cells of people with Parkinson's, can activate the T cells involved in autoimmune attac ks The study was published today in the June edition of Nature Dr Pandurangan Vijayanand and his team demonstrated that tumor immune fitness determines survival of lung cancer p atients In recent years, immunotherapy, a new form of cancer therapy that rouses the immu ne system to attack tumor cells, has captivated the public's imagination When it works, t he results are breathtaking But more often than not it doesn't, and scientists still don' t know why Publishing in the June 2017 issue of Nature Immunology, Dr Vijayanand's team identified a subpopulation of T cells in tumors known as tissue-resident memory T cells (T RM) as an important distinguishing factor between cancer patients whose immune system moun ts an effective anti-tumor response and those who are unable to do so Their finding emerg ed from the first large-scale effort to profile the gene expression patterns of cytotoxic T cells isolated directly from patients' tumors Dr Klaus Ley's lab provided new insight into how neutrophils, the immune system's EMTs, spend most of their lives racing through t he bloodstream constantly on the lookout for bacteria and other foreign invaders Once the y arrive at infiltrated tissues, they halt on a dime and slip through the vessel wall to r each the site of infection Dr Klaus Ley and his colleagues developed a sophisticated int ra-vital imaging method that allowed them to watch in real time how neutrophils control th eir speed as they roll along the walls of blood vessels The dramatic, real-time footage s hows in great detail how neutrophils throw out tube-like tethers to anchor themselves to a void being swept away by blood rushing by at high speed As neutrophils gently roll along, tether after tether is peeled loose and slung forward like a lasso to gain new leverage, slowing them down enough to exit the blood vessel A study by Dr Shane Crotty and his col laborators established important benchmarks for HIV vaccine candidates The development of a vaccine that protects against HIV infections has proven extraordinarily difficult One of the reasons is that nave precursor B cells that can give rise to mature B cells produci ng broadly neutralizing antibodies-a requirement for a successful antibody-based HIV vacci ne-are considered to be exceedingly rare within the average human Publishing in the Decem ber 201 issue of the journal Immunity, Dr Crotty and team were able to show that despite their low frequency these B cell precursors can be successfully primed to prevail over the ir B cell competitors under the right conditions Earlier studies had detected these B cel ls in most humans but at very

By providing an answer, the current study closes the knowledge gap about competition between different immune responses and establishes defined benchmarks vaccine candidates should be compared against for consideration before they are put into clinical trials. Dr. Klaus Ley successfully mirrored the breadth of genetic and immunological diversity found in the human population in the lab by using a panel of about 100 different inbred mouse strains instead of just one. The new approach successfully replicates natural human immune variation in the lab and allowed Dr. Ley and his team to identify a molecular fingerprint that successfully predicted individual people's susceptibility to inflammatory disease as well as survival of patients with certain cancers. Traditionally, researchers have relied on genetically identical mouse strains to gain insight into the complex world of human diseases while reducing what is known as experimental noise. But in contrast to these mice, not two people are genetically alike. As a direct result many promising drug candidates fizzled in the face of human genetic diversity. Competitive Research Grant Funding & Research Awards & Distinctions In 2017, La Jolla Institute scientists continued to attract increasing numbers of competitively awarded research grants attesting to the high level of research productivity present at the Institute. One example is Dr. Catherine (Lynn) Hedrick, Ph.D., a Professor in the Division of Inflammation Biology, who has been awarded a five-year, \$13 million grant by the National Institutes of Health to lead a collaborative research program project to study how functional changes in immune cells contribute to atherosclerosis. The end goal of the study is to identify novel therapeutic strategies targeting immune cell function to reduce cardiovascular disease.
