These services provided them with comfort items (food, clothing, hygiene products, etc.); vital information regarding available resources to meet their needs; apartment support/housing for over 460 kids; educational services for over 800 kids; employment for 147 kids; medical, ID/birth certificate services for approximately 300 youth; and, other resources to assist in alleviating the problem of youth homelessness and prepare them for self-sufficiency.
