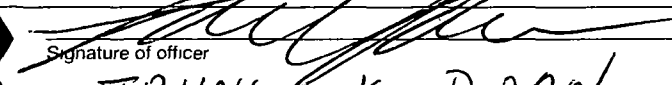

Corrective Surgery Program provided free cataract surgeries for 870 elderly patients in rural areas of the Mekong delta region in southern Vietnam (\$37,894), orthopedic surgeries and equipment for 463 children in 14 provinces in Vietnam (\$128,523), and heart surgery for 5 children in An Giang (\$11,488).

Mobile Health Care Program organized a group of doctors, dentists, pharmacists, nurses, and support volunteers to provide free medical check-ups for 2,530 patients, vision examinations for 2,005 patients, and dental services for 1,577 patients in Chau Phu district, An Giang province. Patients received free two week supplies of medicine, reading glasses, and gifts.

Part VI, line 12: the organization Bylaws, Article 3, Section 6 specifies restriction regarding interested persons. Also Article 11, Section 1 prohibits directors, officers, or other persons connected with the organization against receiving any profits from the organization. To monitor and enforce the conflict of interest policy, the board of directors must review and approve all business transactions of the organization.

Part VI, line 19. To make information available to the public, the organization publishes its Annual Financial Statement in the quarterly newsletter and on its website. The governing documents and Form 990 are kept at the organization office and are available upon request. Form 990 is also accessible on third party web sites as well as the Internal Revenue Service web site.
