In perpetuity sponsorship of annual Tibetan Buddhist Nyingma World Peace Ceremonies at Bodhgaya INDIA, including daily offerings to monastic participants, ceremony offerings of butter lamps, candles, tsog (food), flowers; and daily food offerings to the local poor. Head Lama of TNMC Yeshe De Project religious texts, books and art are transported to Bodhgaya where they are freely distributed to monastic and lay practitioners.

The annual ceremony is on a lunar calendar. Consequently, some years contain support for two ceremonies, and others for none. In 2017 two annual ceremonies were supported, those for Jan/Feb 2017 ceremony, and funding in Dec for Jan 2018 ceremony. 01/10/2017 wire to The Head Lama of the Tibetan Nyingmapa Meditation Center, church, for the Bodhgaya ceremony Jan 28 - Feb 6. Monastic attendance averaged 6818/day for 10 days; thousands of lay people also attended. Daily offerings of flowers, food (tsog), and other ritual objects were made including one million butterlamps. A daily vegetarian meal was prepared and offered to all the local poor. Texts prepared by the Yeshe De Project of Head Lama of TNMC were distributed to the monastic sangha along with small statues and 300 temple prayer wheels for the monasteries. 100 banners with sacred Prajnaparamita Sutra texts were offered. About a dozen TNMC members traveled to the ceremony to assist with text and gift distribution. The assembly chanted for World Peace for 10 days. All of these expenses were under pre-approved and reconciled budget control by Head Lama of TNMC budget committee.

12/05/2017 Wire to The Head Lama of the Tibetan Nyingmapa Meditation Center for the annual Bodhgaya ceremony Jan 17-26, 2018. About 7000 monastics and thousands of lay people attended. Daily offerings included flowers, rice, tsog (food) and 100,000 butter-lamps as well as daily vegetarian meals for the local poor. Lodging and transportation was paid for monk helpers and about 10 western pilgrims who assisted in ceremony book and offering distributions. Trucks were hired to bring the book shipments from Kolkata to Bodhgaya where sacred texts produced by Yeshe De Project were given away for the 29th consecutive year since 1989. These expenses were according to a preapproved budget approved by the Head Lama of TNMC budget committee

Part IV section D3: Supported organization's voice in investment policies and in directing use of organization's income or assets

The Head Lama of the Tibetan Nyingma Meditation Center (TNMC) is the supported organization of the Bodhgaya Religious Trust. The assets of the Bodhgaya Trust are all in a Vanguard account. The Vanguard account manager met with members of the Board several times during the year to discuss the investment performance, policies and asset allocations of the account. These members include the Head Lama and President of TNMC who is also President of the Board of the Bodhgaya Trust, as well as the Treasurer and other members of the Board. In addition, monthly statements and quarterly performance reports are sent to the Treasurer and the office of the Head Lama of TNMC. Head Lama meets with members of the Board and yearly establishes a detailed budget for the annual ceremony. At the end of the ceremony, a report is made reconciling the budgeted and actual expenses for that year's ceremony. Any carryover funds and leftover funds are accounted for and deposited with the ceremony committee of monasteries in India for use the following year. Head Lama oversees these budgets and reports and shares them with the Bodhgaya Trust Board. Signatories on the Vanguard account are all members of the Bodhgaya Trust board.

Part IV section E, box 2 Activities Test

The Bodhgaya Religious Trust is engaged in a direct furtherance activity of The Head Lama of the Tibetan Nyingma Meditation Center, a church. This Trust holds the endowment funds for the furtherance of the annual Nyingma Bodhgaya Peace Ceremony so that the ceremonies may continue in perpetuity. As noted above, investment and disbursement policies are made in collaboration with TNMC. The church directs activities of the Bodhgaya Trust according to the founding principles of the Trust which is an integrated auxiliary of the church. If there was no support by the Bodhgaya Trust, then Head Lama of TNMC would itself have to endow the ceremonies or find another means of continuity for the in perpetuity sponsorship of the ceremonies. Preservation of the Tibetan Nyingma lineage traditions is an integral purpose of The Tibetan Nyingmapa Meditation Center. These Asian practitioners are supported by having the opportunity to participate in their traditional rituals of large gatherings: they are the lineage holders of the tradition.
