Provided 20 water projects within the state of Andhra Pradesh, between the Visak and East Godavari Districts. These projects were taken up by our indigenous partner, Society for Helpless and Economically Backward Areas (SHEBA). The impact of the water projects in these 20 places is estimated at 13,000 rural men, women and children. In addition to the water, funding assistance was also provided for a micro finance program that touches over 1,000 rural women and a children's home of 220 semi orphan and orphan kids. Within the same area, we worked alongside SHEBA's parent organization, Nazareth Association for Social Awareness (NASA) and provided some emergency water camps, assistance to those impacted by HIV/Aids and Leprosy, along with funds for a medical camps impacting the lives of 500 rural men, women and children and community outreach towards those displaced by natural causes or considered landless nomads.

4b (Code:) (Expenses \$ 29,740.00 including grants of \$ 20,300.00) (Revenue \$ 1,242.00)

Provided 12 water projects within the state of Tamil Nadu, primarily within the Trichy District and these projects were taken up by our indigenous partner, Depressed People's Welfare Association (DPWA). The impact of these 12 projects is estimated at 10,000 rural men, women and children. In addition to the water, financial assistance was extended towards a community outreach program which would impact at least 500 men, women and children.

Provided 15 water projects within the states of Telangana, Karnataka and Andhra Pradesh through our indigenous partner Green Connexion. The impact of these 15 projects is estimated at 11,000 rural men, women and children.
