IT IS DESIGNED AS A PATHWAY FOR ENVISIONING, DEVELOPING, AND LAUNCHING A SOCIAL ENTERPRISE - SOMETHING PURPOSELY CREATED TO ADDRESS A SOCIAL OR ENVIRONMENTAL ILL.
