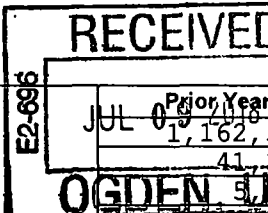

During the years 2017 and 2016 Alianza Americas was the fiscal agent for the Global Coalition on Migration (GCM) and Presente.org (2017 only). Accordingly, revenues and expenses related to GCM and Presente.org are not included in Alianza Americas' statement of activities and net assets. For the years 2017 and 2016 Alianza Americas realized a fiscal agent management fee of \$35,310 and \$8,580, respectively.

Part XIII Supplemental Information *(continued)***Part X - FIN 48 Footnote**

Alianza Americas is exempt from federal taxes under Section 501(c)3 of the Internal Revenue Code. It qualifies for charitable contributions under Section 170(b)(1)(A), and has been classified as an organization that is not a private foundation under Section 509(a)(2). The management of Alianza Americas has determined that FIN 48, which addresses accounting for uncertainty in income taxes, has no effect on its financial statements due to its tax-exempt status.
