Super Shot serves children from birth through age 18 that are eligible for the Vaccine For Children Program (Medicaid eligible, uninsured, underinsured) and now we are able to serve adult family members with nine different vaccines: Hepatitis A and B; Tdap, MMR, TD, Varicella, Polio, HPV and Flu. In 2017, Super Shot provided 26,274 immunizations to 7,253 children in 9,178 clinic visits. We provided 487 adult vaccines to 280 adults in 302 visits. Our Reminder/Recall Program placed 13,303 autodialed telephone calls, 7,240 personal telephone calls to families of children ages 0-18 years of age. We also mailed 8,585 postcards. Of the children we serve 86% of families have incomes at or below 200% of the poverty level; 29% have no insurance. 8% are headed by single females; 45% are from minority families; 29% are behind in their immunizations; 57% qualify for Medicaid; 38% reside in medically underserved areas; and 6% reside outside of Allen County.

HISTORY:

Super Shot was founded in 1992 to address the critically low immunization rates in Allen County. Free immunization clinics were opened on designated Saturdays at various sites around the city twice each year. In the fall of 1998, changes in federal funding coupled with new state laws mandating additional shots for children entering school, resulted in an unprecedented health crisis for our community. To alleviate this crisis, Super Shot began operating free weekly immunization clinics in the evenings and on weekends in neighborhoods convenient for families.

Today, we operate community immunization clinics at four sites throughout Allen County and conduct a monthly Reminder/Recall program to remind parents their child is due or past due for an immunization. We also educate parents about the importance and safety of vaccines. We work with schools and local not-for-profit agencies to educate their staff and the parents they serve about immunizations and the state immunization data base. In August 2014, the state began providing Hepatitis A, Hepatitis B, and Tdap vaccines to Super Shot for uninsured adults. HPV was added to the list of vaccines for 2015 and the eligibility requirements were expanded to the underinsured. The ability to offer vaccines to adult family members allows Super Shot to make an even bigger impact on community health and supports our mission because parents who are immunized help protect their children's health from these diseases and these parents are also more likely to continue to have their children immunized.

Services Provided: As a Vaccines for Children Provider, Super Shot provides immunizations against flu and over 15 other vaccine preventable childhood diseases to children ages birth to 18 who are uninsured, underinsured, or Medicaid eligible. ~~Our largest program is our network of nine immunization clinic sites.~~

Community Immunization Clinics: Our clinics are located at four convenient, family-friendly sites in churches and medical offices in Fort Wayne and Grabill. Clinics are staffed by six nurses with experience administering immunizations.

Reminder/Recall: Autodialed and personal telephone calls, postcards and emails are used to contact families to remind and recall them when a child is due or late for immunizations. Through the Reminder/Recall Program, families are contacted BEFORE immunizations are due and AFTER a child has missed an immunization to help families stay current with their child's vaccines.

Project Immunize: Focuses on educating new parents and child care providers and providing immunizations to infants through age two. This age is critical as 80% of the immunizations on the CDC's recommended immunization schedule are to be given before age two. This age group is also our most vulnerable population for disease. With the support of the local hospitals, we provide parents of all infants born at the local hospitals with our Super Shot Health Passport. This booklet contains helpful tips for parents, growth records and a convenient place to record children's immunizations. Inserts in the booklet provide our clinic calendar, and reliable website addresses with immunization information. The booklet also includes information about health insurance for themselves and their children through the Coverings Kids and Families Coalition.

We added an additional insert to all passports in 2015 to inform families about the availability of adult whooping cough vaccine (Tdap) at Super Shot. We made this insert so parents wouldn't miss it. It is a small bright red business card that states "Tdap (whooping cough) vaccination is available for expectant parents and

parents, household members and family caregivers of an infant less than 12 months. Please call for eligibility information and learn more about our adult vaccine program 260-424-"SHOT" (7468)". Babies are more likely to die from whooping cough or suffer from complications. The outbreaks of pertussis have been increasing since the 1980's with a 15% increase from 2013-2014. We educate parents and give them information at our clinics about "cocooning" their infant. The most important step a parent can take is to make sure all adults and family members in contact with their baby are vaccinated for whooping cough and flu.

Project Immunize also conducts monthly Reminder/Recall activities targeting the 0-2 age group. Our Project Immunize Reminder/Recall program includes several methods to reach families: 1) postcards with a family friendly immunization schedule printed on them are sent to families when a child has missed the opportunity for immunizations; 2) autodialed phone calls are made to families to recall children who missed the opportunity when shots were due; 3) personal phone calls are made by a nurse to families with children from ages 0-2 years of age who are due for a shot in the following month and personal phone calls are made when children ages 11-18 months of age have missed the opportunity for immunizations. These ages were selected because we have historically seen children drop off the schedule during this time. These personal phone calls by a nurse provide an opportunity to talk directly with parents to explain the importance of immunizations and to answer any questions they may have. This proactive approach has proven to be very effective.

Parent Education: Super Shot works extensively in the community and at our clinics to provide education and information to parents. We have printed 21,000 copies of our updated clinic calendars and approximately 6,000 copies of our Super Shot Health Passports for distribution. At the clinics, we provide parents with vaccine information statements, immunization records and information on how to access their child's records on the new state website myvaxindiana.in.gov. This

promotes understanding of the importance of vaccines and personal accountability for keeping their child up-to-date with immunizations. Our staff use the CASE method (Corroborate, About You, Science and Explanation) created by the National Autism Foundation when providing education about immunizations. This method provides science based information to help parents make the best decision about immunizing their children. We are seeing success with the CASE method as more parents are indicating they understand the importance of vaccines (99%) and the percentage of vaccine refusals has decreased from 11% in 2012 to 6% in 2015. This method provides parents the information they need to make their own decisions so that they can exercise their own self-reliance and are accountable for their children's health.

We also partner with hospital education programs to reach parents-to-be and newborn parents about the importance of immunizations. Our education coordinator presents information to parents at Parkview Regional Medical Center twice monthly; to New Moms groups at Dupont Hospital on a quarterly basis; and to the Lutheran Hospital Breastfeeding group. Because there is no organized education at St. Joseph Hospital, we are on call for any parent that would like more information about immunizations. Our education coordinator also works with local not-for-profits such as the A Hope Center (all locations) to educate parents in their care and we continue to seek organizations that would benefit from our assistance.

Community Outreach: As another avenue to reach parents and expand awareness about our program and the importance of vaccines, we work extensively in the community to provide education and information to staff of other not-for-profits that are responsible for keeping children up-to-date with immunizations, school nurses, and staff at local hospitals and private healthcare providers. When any outbreaks of disease occur, we collaborate with partners to create responses using educational materials and community outreach. We also partner with agencies to provide education for their clients and participate in numerous community events such as

COMMUNITY NEED

~~Newborn babies are immune to many diseases because they have antibodies they got from their mothers. However, this immunity goes away during the first year of life.~~

If an unvaccinated child is exposed to a disease germ, the child's body may not be strong enough to fight the disease. Before vaccines, many children died from diseases that vaccines now prevent, such as whooping cough, measles, and polio. Those same germs exist today, but because babies are protected by vaccines, we don't see these diseases nearly as often.

Immunizing individual children also helps to protect the health of our community, especially those people who cannot be immunized (children who are too young to be vaccinated, or those who can't receive certain vaccines for medical reasons), and the small proportion of people who don't respond to a particular vaccine.

The CDC has identified high cost of vaccines, lack of knowledge about the importance of vaccines, and lack of access as barriers to immunization. Super Shot breaks down these barriers and makes vaccines accessible for children. Super Shot is the most effective immunization program ever operated in Allen County and has received recognition at the state and national level for its effectiveness. Super Shot is the ONLY non-profit immunization program in our community that provides immunizations to children during multiple evening and weekend hours. TARGET POPULATION

Population Served: Super Shot serves children from birth through age 18 that are eligible for the Vaccine For Children Program (Medicaid eligible, uninsured, underinsured).

In 2017, Super Shot provided 26,274 immunizations to 7,253 children in 9,178 clinic visits. We provided 487 adult vaccines to 280 adults in 302 visits.

Our Reminder/Recall Program placed 13,303 autodialed telephone calls, 7,240 personal telephone calls to families of children 0-18 years of age. We also mailed 8,585 postcards.

Of the children we serve: 88% income at or below 200% of the poverty level; 29% no insurance; 8% single female head of household; 45% minority families; 29% behind in their immunizations; 57% Medicaid; 38% reside in medically underserved areas; 6% reside outside of Allen County.

COLLABORATION WITH OTHER LOCAL SOCIAL SERVICE AGENCIES

Super Shot is an independent 501(c)3 not-for-profit agency funded by private donations from foundations, corporations, and individuals. We work with all local hospitals and schools systems, Neighborhood Health Clinics, and the Department of Health (DOH). Our program compliments the services of (DOH) by providing services at times and locations it does not serve. We also work with local child care facilities assisting them with keeping children in their care up-to-date on their immunizations. We partner with churches and hospitals to ensure that our clinic sites are in safe, clean, and accessible locations. We will also continue our partnership with Walgreens in which they distribute free adult flu vaccines to

uninsured and underinsured families at our clinics during flu season.

BUILDING ON PEOPLE'S STRENGTHS

It is easy to take good health for granted. But when our health is compromised, ~~even temporarily, our life can be drastically affected. Super Shot builds on people's~~ strengths and helps them become more self-sufficient by helping to ensure they can continue their normal daily routines. Keeping children healthy and safe from childhood diseases means they are able to attend school, participate in activities, and continue to grow and learn. For families, keeping children healthy means less time off from work to take care of a sick child or to take them to the doctor. We also educate families about flu vaccines by providing them with science based information so that they can make the best decision for their own family. We provide them with information about the importance of vaccines; the CDC recommendations regarding vaccines and the recommended vaccine schedule; and information about scientific studies that have proven the safety of vaccines. Super Shot also provides families with the tools to keep record of their children's immunizations so that they can continue to obtain immunizations for their children as they grow. Families have more control over their children's health care. All of these factors increase self-sufficiency.
