Haiti: Since the devastating earthquake in 2010, Haiti's Ministry of Public Works worked with Build Change to develop building guides for safer houses. Ministry enforcement will allow thousands of homeowners to be protected in the coming years. We have completed 1,500 houses using these guides and have influenced the construction of thousands more. REZO, a network of trained construction professionals, has now garnered support from government agencies. The REZO certification process provides builders with the expertise to build safer schools and homes, while increasing their earning potential. Nearly 200 builders were trained last year. Since its inception, REZO block makers have sold 13 million high-quality blocks, contributing to an estimated 24,000 safer homes. In partnership with the Haitian Ministry of Education, Build Change developed tools to evaluate public school buildings and improved strategic decision-making processes for school rehabilitation projects. Thirty-six engineers from the Haitian Ministry of Education were trained to perform architectural and structural evaluations, and ultimately assessed seventy-one public schools around the country. In the wake of last year's Hurricane Matthew, trainings in safer construction techniques have been conducted for builders in southern Haiti. By leveraging current partners and the REZO network, we can now implement these trainings more quickly than ever before. Each year, we increase Haiti's resilience to future storms and earthquakes.

Indonesia: In 2017, forty students who attend school in Padang are now safer. This project successfully demonstrated that the more than 1,000 vulnerable school buildings in the area can be strengthened using simple, cost-efficient retrofitting techniques. The Bata Jaya brickmakers cooperative has expanded its market to four districts in West Sumatra. The cooperative is now using improved marketing, billing, payment, and supply chain strategies to increase its sales capacity. Two disaster-resistant timber-frame model houses were constructed during an awareness-raising campaign in Pidie Jaya after the December 2016 earthquake in the area. As a result, 80% more people in the area regard timber-frame housing as being safer in an earthquake.

Philippines: In Metro Manila, eight houses benefitting 14 families were retrofit in 2017 using an innovative "Pay What You Can" loan structure. At the end of 2017, loan recipients demonstrated an average repayment rate over 99%. By aligning this loan program with the local financing market, Build Change plans to offer this program to more homeowners around Metro Manila in 2018. The Ramon Aboitiz Foundation, Inc. (RAFI) built more than 300 safer classrooms in 2017 using the safer tools and designs we provided. This partnership has been incredibly efficient, rendering students safer at a cost of just over one dollar per child. We will continue to support RAFI to build safer schools in the years to come. The Swiss Red Cross and Philippines Red Cross used our new tools to design and build safer timber houses. More than 470 safer houses were built in 2017, which made 2,050 people safer at a cost of about \$17 per person.

As part of another pilot program in Bogota, Colombia, nine families were selected to retrofit their houses. As a result, the Bogota city housing unit seeks to expand the program to reach many more local families in the next year. By leveraging government home improvement subsidies to seismically retrofit houses, the program is now poised to scale in other Colombian cities. Medellin, another Colombian city at risk of catastrophic loss of life in the next earthquake, is now leading a retrofit program. The city government has received its first training. Additionally, our engineers designed the first round of retrofits and submitted the first seven designs for construction permits. The city of Cali has expressed interest in becoming our next partner as we continue to scale our retrofitting program around the country. Following the two earthquakes this past September, Build Change sent a team to Mexico to research and make recommendations on improved reconstruction.

**Nepal: Program Expenses \$1,437,857 Grant Revenue \$40,655 Total Revenue \$1,627,673**

Nepal: In Nepal, the Surakshit Ghar mobile application allows thousands of rural homeowners and builders, still rebuilding after the 2015 earthquake, to access safer building designs. This game-changing technology was endorsed by the Nepal Government to support country-wide safe and efficient reconstruction. This year alone, the app has facilitated technical assistance for thousands of earthquake-affected families. Following government approval of a retrofit type design in June, the Ministry of Urban Development requested an introductory training to all 2,000 government reconstruction, to thousands of families like Ishwari Majhi's. A second school building in Sindhupalchowk is now safer for the dozens of students studying there, and 700 houses were reconstructed by the end of the year.

**Innovations: Program Expenses \$242,150 Grant Revenue \$164,000 Total Revenue \$164,122**

In addition to its country-specific programs, Build Change has several initiatives that support all of its programs and its world-wide mission in the areas of engineering, education and advocacy and promotion. It includes training for all of its engineers and trainers, as well as participation in several conferences and programs across the globe that aim to increase awareness of its approach to building houses and schools that are resistant to natural disasters in emerging nations.

The approval of the CEO's compensation is documented in the Board minutes. The CEO reviews and approves the salary of top management officials. The Board preapproves any new hires and their salary range by virtue of approving the budgets. If a top management personnel is hired outside of the previously approved budgets, the Board is informed of the details and approval is requested.
