②⑧ Throughout the year we provide food for the homeless and emergency food for the needy. We also provide funds to help with evictions, utilities cut-offs, medical bills and travel expenses. We also provide cleaning items, toiletries and paper supplies to a senior citizen apartment building. We served over 600 people through the programs.

②⑨ We assist refugees with translators to accompany them when they apply for government programs. We also assist them with emergency funds the same as the others above. The refugees are primarily from Syria. We served over 300 refugees.

③⑩ Day of Dignity is a yearly neighborhood event. We provide a hot meal, toiletries, clothing, health screenings and education, housing and employment referrals. This event serves 400 clients each year.
