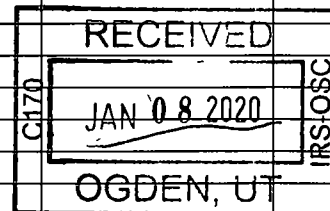

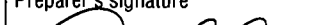

The Foundation did not receive its Determination Letter until 2/16, 2018 and did not become active and had no activity of any kind except for a single contribution by the grantor of the Foundation made on 12/28/2017. There was no activity of any kind in 2018 and no activity until the end of 2019 which brought the current situation to the forefront. In addition, the formation of the Foundation was handled exclusively by a law firm in Atlanta, Georgia and, apparently, there was confusion between that law firm and the grantor's Form 1040 tax preparer concerning the Foundation's filing responsibilities. As this is a new Foundation and the oversight was corrected as soon as discovered and that any penalties will only diminish the funds available for the Foundation to further its charitable purpose, the grantor respectfully requests a waiver of the failure to file penalty.
