Awardees are selected by five national jury panels that convene in Chicago and are comprised of artists, curators, presenters, and leaders in their fields. Managed by the Alliance of Artists Communities, 3Arts Fellowships take place at the Camargo Foundation in France, Djerassi Resident Artists Program in CA, the Joan Mitchell Center in LA, and the Rauschenberg Residency in FL. 3Arts also offers a residency in partnership with the MacDowell Colony. Additionally, we provide customized, in-town residencies for artists with disabilities through a partnership with Bodies of Work and the UIC's Department of Disability & Human Development.
