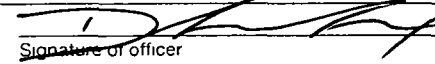

Shipping Medical Supplies and Equipment: Most mission hospitals lack important medical equipment and even basic supplies. Global Health Ministries (GHM) gathers donated medical items, from exam gloves to ultrasounds, and matches them to requests from partners in developing countries. We purchase and ship new equipment as well, making quality health care accessible for some of the world's most vulnerable people. In 2017, GHM shipped 11 sea containers in support of hospitals and clinics in 6 countries. Travelers hand carried medical supplies and equipment in 145 suitcases to 31 different countries.

Capacity Building: GHM manages diverse capacity-building projects: scholarships, water, education, agriculture sanitation, income generation, ect. All these efforts focus on enhancing our international partners' capacity to make measurable and sustainable improvements in the health of their communities and health care.

Consulting: Upon request, GHM offers consultants in governance, management, and leadership for health leaders in the developing world, through our consulting department, GHAP (Global Health Administration Partners). In 2017, GHAP conducted four consultations in three countries. The purpose of GHAP is to establish or enhance long-term relationships with faith-based health facilities in order to improve those facilities' long-term ability to provide health care.
