THE ILLINOIS FIREFIGHTERS MEMORIAL IS MAINTAINED BY THE FOUNDATION. THE ANNUAL FIREFIGHTERS MEMORIAL SERVICE AND RECOGNITION IS CONDUCTED BY THE FOUNDATION. FUNDING IS PROVIDED BY DONATIONS FOR MEMORIAL BRICKS THAT ARE ADDED TO THE MEMORIAL MONUMENT EACH RECOGNIZING A FALLEN FIREFIGHTER. ALSO, FUNDING IS PROVIDED BY THE STATE OF ILLINOIS THROUGH ISSUANCE OF SPECIAL AUTOMOBILE LICENSE PLATES WITH A PORTION OF THE PROCEEDS FROM THE SALE OF THOSE PLATES ALLOCATED TO THE FIREFIGHTERS MEMORIAL FOUNDATION.
