**The vision of Koinonia House® National Ministries (KHN) is to glorify God through the redemption of our neighbors in prison by the gospel of Jesus Christ and their continued discipleship out of prison, thus reducing the recidivism rate. Our mission is to bridge the gap between the Christian inmate and the local church by facilitating the integration of the former inmate into the church, workplace, and society through biblical discipleship.**

**MEET ME AT THE GATE®:** Since 1997, KHN has been working with churches, organizations, and individuals in ministering to Christian neighbors coming out of prison for whom no family-home-based program is available. Since 2008, it has worked through its affiliate organization, Koinonia House® of Wheaton (KHW), to provide Christian men coming from prison a residential family-home-based discipleship program. In 2017, KHN assisted 35 individuals/families with re-entry issues, and five men resided at the KHW.

Average weekly attendance at Radical Time Out™ (RTO) in 2017 was 90. RTO is an evening of dinner, fellowship, prayer and worship, where everyone is welcome to experience the love and grace of Jesus Christ, regardless of color, class, culture, crisis, or crime.

**IN-PRISON MINISTRIES:** In 2017, KHN conducted Freedom God's Way events in 8 adult correctional centers for over 900 men and 60 women in the Illinois Department of Corrections. These multi-day events focus on presenting the Gospel of Jesus Christ and preparing inmates for their return to society through Bible teaching, life skills, singing, story-telling, confession of sins, and communion. Christian literature and Bibles are distributed when allowed. Staff & volunteer teams ministered regularly at Cook and DuPage County Jails, and monthly at Pontiac, Sheridan, Stateville Correctional Centers in Illinois.

Correspondence is another in-prison ministry vehicle. In 2017, KHN responded to 276 inmate letters and the RTO family held two "card showers" -- writing notes of encouragement to 39 inmates directly connected to those attending RTO.

In addition to regular ministry within Illinois, KHN conducted special services in jails and prisons in Indiana, Minnesota, Nevada, and Wisconsin. A 2017 highlight was ministering in La Modelo and La Picota--two of Colombia's notorious prisons in Bogotá.

**GENERAL:** Expenses in this category cover activities such as helping families of incarcerated individuals, educating the public on the need of people returning to society from prison, and ministering to donor families. In 2017, KHN staff assisted 33 individuals and families through formal and informal advisory sessions. KHN staff members also spoke/taught on 7 radio/TV programs and 1 podcast; ministered/spoke at 16 services in 5 churches, 3 schools, and 1 parachurch ministry.

2017 highlights include partnering with Calvary Chapel Las Vegas in open-air evangelism in Mazatlan, Mexico; participating at ExpoLit in Miami, FL where the CEO/Operations Director spoke on 21 radio/internet broadcasts for 19 stations that reached into 15+ nations; and a 2-hour radio program with CREA Radio in Bogotá, Colombia.

KHNM held its first Radical Prayer Conferences in 2017 -- at a local church in Philadelphia, PA and at two prisons (Oakhill Correctional Center in WI, Hill Correctional Center in IL). Oración Radical (the Spanish edition of KHNM's book Radical Prayer) was released in September 2017, and KHNM participated in events in Bogotá, Colombia for the launching of the book into Spanish-speaking churches. Copies of Radical Prayer (1,964) and Oración Radical (344) were distributed to individuals while ministering in 16 churches, 23 prisons, and 4 schools/para-church organizations.
