<p>28</p> <p>Continuing on our program of upgrading nutritional requirements for our veteran participants we expanded our knowledge base through directed studies and consultations This was a high priority because many veteran participants who come to Valhalla have experienced significant improvement with symptoms previously thought to be PTSD related, yet only a few weeks on a nutrient dense natural foods program often results in marked reduction of symptoms such as anxiety, insomnia, chronic fatigue, headaches, irritability, and other PTSD-mimicking malnutrition problems In an effort to provide more high quality food items for our veteran participants we expanded our poultry flocks and directed increased attention to vegetable garden plots and orchards These efforts dovetailed with our continued expansion of the Valhalla Project's unique permaculture design for the grounds, pastures, forests, and wildlife habitats with post-9/11 veterans accelerating some key elements focused on long term environmental goals Our plan to teach Valhalla participants more in depth about nutrition, overall health benefits of eating well, and preparation of delicious meals for themselves and families continues to be very productive and useful We formally instruct participants in healthy nutritional practices with emphasis placed on freshness of ingredients, variety of foods, and ease of preparation, imparting a sense of self-confidence and comfort to veteran participants who had little or no cooking experience In this case while practice does not necessarily make perfect it improves tremendously on the level of training and experience our veteran participants have had with food preparation and cooking</p> <p>(Grants \$ 42,372)</p> <p style="text-align: right;">If this amount includes foreign grants, check here . . . <input type="checkbox"/></p>	<p>28a</p>
