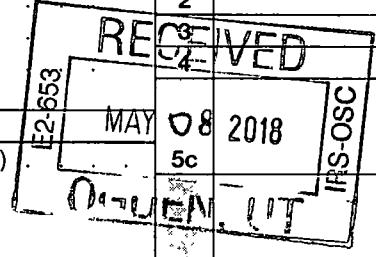



The name of the organization comes from Isaiah 43:6-7,21. This ministry was birth of prayer in the spring of 2011. God is bringing people of all nations to this country; many are coming for a better life. The churches have the of sharing the truth and love of Jesus Christ to each and every one of the immigrants, refugees, and international students. To that end i43 prayer meetings, evangelism seminars, missionary training workshops, short term missions and outreach events. i43 also established ESL c Leesburg in the fall of 2013 to help the local churches engage with the immigrant community and provide practical help regardless of their ethnic or religious background. During the past 2-3 years we have also helped 4 local churches to launch their own ESL ministry. We are planning to start another ESL ministry at a church in Centreville

Missions - Short term mission trips to countries of interest in fulfilling the Great Commission (Matthew 28:19,20); mentoring missionaries on the field; helping indigenous churches with ministries;
