RACC educators present Red Flag Green Flag (second grade) and I Wish the Hitting Would Stop (fourth grade) to Fargo, West Fargo and Moorhead students. In 2017, RFGF was revised and will be piloted in 2018. FM metro area second grade teachers were surveyed (n = 70) to gain their perspectives on the RFGF curricula and its impact on their students. Of the teachers surveyed, ninety-eight percent reported that RFGF was valuable to the students receiving the classroom.
