The purpose of the 1200 Fund is to provide low or no interest loans and other financial assistance to businesses located in or near the City of Duluth in order to confront economic deterioration and loss of jobs around the area. The financing is intended to provide assistance to business that are not able to obtain affordable, adequate, or appropriate financing from other conventional sources.

The primary requirement of the assistance is that the recipient provides for new job creation and/or retention of existing jobs.

There were three new loans approved and drawn down in 2017. All three loans contain a provision for loan forgiveness based on the number of new jobs created and maintained for a specified period of time.

A total of \$433,484 and \$8,224 in loan principal and interest repayments were collected during the year.

In 2017 we also reached a partial settlement with a distressed borrower and eventually wrote off the remaining delinquent principal & interest balances of approximately \$245,281. As a result of the settlement and subsequent writeoff, the borrower avoided bankruptcy and was eventually purchased by one of its customers. The loss of thirty good paying, high quality jobs was avoided.
