Form 990, Part III, Line 4a:

Parenting the Future With Purpose (PFWP) provides parenting education and support for incarcerated parents who have a desire to increase their parenting skills and improve family relationships in preparation for a return to their homes and communities. PFWP is currently facilitating parenting classes in the Minnesota Men's Correctional Facility in Faribault (MCF/FRB), Rush City (MCF/RC), Lino Lakes (MCF/LL) and the Hennepin County Adult Detention Center for women. PFWP also provides supportive home visits to encourage appropriate behavior in home and the schools for the children and to assist the caregivers in their efforts to raise the children who have been affected by incarceration of a parent. Upon release from prison, PFWP also provides transition support services to those moms and dads who desire to be reunited with their children and live in the metro area of Minneapolis and St. Paul, Minnesota. In 2017, the following goals and accomplishments were achieved: *PWP provided support services to 63 guardians and released parents who have the demanding task of raising children affected by incarceration. *PWP provided 37 parent education classes to 114 women at the Hennepin County Adult Detention Center. *145 parent education classes to 260 men at the Minnesota Correctional Facility (MCF-FRB) in Faribault, Minnesota. *50 parent education classes to 100 men at the Minnesota Correctional Facility (MCF-LL) in Lino Lakes, Minnesota. *21 parent education classes to 60 men at the Minnesota Correctional Facility (MCF-RC) in Rush City, Minnesota. Through these support services the following organizational goals were reached: (1) PWP has played an integral part in discontinuing the intergenerational cycle of criminal behavior in over 637 families. (2) After classes, we surveyed the participants and had the following results: 92% of the incarcerated parents that served rated themselves higher in their parenting skills after they completed their parenting classes, 90% of the parenting program graduates became more involved in their children's school from the prison, 96% of the parents released acquired a job or schooling, 100% of the released parents acquired safe housing, 96% of the released parents remained crime-free.

Form 990, Part III, Line 4b:

The Mentoring For Life Change (MLC) program is a one-on-one mentoring program created to break the intergenerational cycle of criminal behavior in youth affected by parental incarceration. Since July 1999, MLC has made inroads in strengthening family relationships, improving or maintaining good behavior and academic progress in school, increased community service and career awareness in the lives of at-risk youth. MLC program focuses on the expansion of services Parenting With Purpose (PWP) provides to children and families affected by parental incarceration. This program is developed in response to a specific inmate need for assistance to restore and strengthen family relationships and to reduce and prevent the cycle of child abuse and neglect in families with an incarcerated parent. This expansion includes more intense services to the children and their families. PWP believes that as a family is strengthened they will be a greater asset to our communities. The strengthening we believe is holistic, including living a healthy lifestyle by maintaining regular check-ups for the children and the adults, eating healthy, exercising regularly, and learning skills to reduce stress. The expected outcomes of MLC program are as follows: To improve relationship with youth of incarcerated parent and their guardian(s); To improve academic and school behavior for program participants; To improve the physical health and emotional well-being of children, youth of incarcerated parents, and their parents by increasing their awareness in different areas of their lives; To reduce the criminal activity in the children/youth of incarcerated parents. In 2017, the following accomplishments were achieved: (1) Weekly support services (rides, support group and home visits) to 51 children, age 5-25, who have or had an incarcerated or released parent; (2) In the lives of the 51 children and teens that are involved in the MLC program, 100% were not involved in any criminal behavior throughout their year of involvement with Parenting With Purpose; (3) 98% of the children and teens who were actively involved with PWP were able to remain in contact with their parents who were incarcerated or released; (4) 95% of the families involved in the Mentoring for Life Change program reported/showed improvement in the family relationships; (5) 100% of the children and teens regularly involved with PWP have continued to attend school; 92% have shown some improvement or maintained their academics or continued good behavior in school.
