Winona Area Ambulance Service, Inc. responded to approximately 3,418 calls in 2017, of which 2,536 were transported for medical services. In 2017 Winona Area Ambulance Service had 26 standbys. Winona Area Ambulance Service, Inc. is an advanced life support service that provides coverage for approximately 100 square miles, including the cities of Winona, Goodview, and other surrounding communities in Minnesota and Wisconsin. We provide 911 coverage, non-emergency calls, transfers, standbys, and intercepts for surrounding basic life support services. We also provide training and continuing education for area emergency responders and healthcare providers.
